

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.aspirecyber.com](http://www.aspirecyber.com), and Aspire Cyber, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Aspire Cyber, LLC include [www.aspirecyber.com](http://www.aspirecyber.com). The Aspire Cyber, LLC website is a business information site. By using the Aspire Cyber, LLC website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Aspire Cyber, LLC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Employer
- Job Title

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Aspire Cyber, LLC collects and uses your personal information to operate and deliver the services you have requested.

Aspire Cyber, LLC may also use your personally identifiable information to inform you of other products or services available from Aspire Cyber, LLC and its affiliates.

## Sharing Information with Third Parties

Aspire Cyber, LLC does not sell, rent or lease its customer lists to third parties.

Aspire Cyber, LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Aspire Cyber, LLC, and they are required to maintain the confidentiality of your information.

Aspire Cyber, LLC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Aspire Cyber, LLC or the site; (b) protect and defend the rights or property of Aspire Cyber, LLC; and/or (c) act under exigent circumstances to protect the personal safety of users of Aspire Cyber, LLC, or the public.

### **Tracking User Behavior**

Aspire Cyber, LLC may keep track of the websites and pages our users visit within Aspire Cyber, LLC, in order to determine what Aspire Cyber, LLC services are the most popular. This data is used to deliver customized content and advertising within Aspire Cyber, LLC to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Aspire Cyber, LLC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Aspire Cyber, LLC website.

### **Use of Cookies**

The Aspire Cyber, LLC website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Aspire Cyber, LLC pages, or register with Aspire Cyber, LLC site or services, a cookie helps Aspire Cyber, LLC to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. - Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Aspire Cyber, LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

### **E-mail Communications**

From time to time, Aspire Cyber, LLC may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication.
